

Privacy Policy



Purpose

The *Leopold Football Netball Club Inc.* is committed to protecting your privacy and managing your Personal Information in accordance with the *Privacy Act 1988 (Cth)*. This privacy policy outlines how the Leopold Football Netball Club Inc. (LFNC) collect, store, use, and share personal information.

This policy applies to all members, officials, sponsors and volunteers of the LFNC and all activities, services and events offered by the LFNC.

What personal information we collect and why do we collect it?

The types of personal information we may collect includes name, date of birth and contact details. We also collect sensitive personal information such as gender, memberships or accreditations (e.g., First Aid, WWC etc.) and medical and health information.

Personal information is collected for the administration and delivery of sporting services and activities to you as a participant, as a player, parent/guardian, coach, manager, medical/trainer, volunteer, administrator, official, spectator, employee, service provider or sponsor of the LFNC. Your personal and sensitive information may also be recorded as part of any medical and reporting requirements as required by law.

Other personal information

We may collect, use and share other personal information in relation to your involvement (e.g., playing statistics, employment, social media profiles and credit card or payment records). This information may be used by LFNC for the purposes of marketing, media and sponsorship or promotional activities.

How we collect your personal information

LFNC may collect information directly from you via registration with PlayHQ and/or Club membership portal, through email, SMS and phone calls and other types of direct communication with you. We may also collect

information about you from third-parties and affiliated organisations (other AFL/Netball clubs and coaches) or from LFNC officials, coaches, medical teams and players.

Sharing your personal information

LFNC may disclose personal information to other organisations and businesses where there is a need to as part of LFNC delivering its services and activities. The types of personal information shared will depend on your role at LFNC. Organisations we may share information to may include:
