Thank you for returning our completed license agreement for THE WIZARD OF OZ (RSC) to be presented for 3 performances from September 11, 2014 to September 13, 2014.

We have scheduled the rehearsal material and orchestration to arrive four months prior to your first performance date.

You are entitled to receive the rehearsal material 3 months prior to your first performance date at no additional charge. Beyond that period of time there is additional rental of \$125.00 per month pro-rated by the 1/4 month. The additional rental to receive the rehearsal material one month early will be \$125.00.

The orchestration rents separately from the rehearsal material at \$295.00 per month with a one-month minimum rental charge prior to the first performance date which also includes use of the orchestration during the first calendar week (Monday through Sunday) of performances.

We wish to confirm a royalty and rental quotation of \$2,205.00 for the first performance and \$1,885.00 for each additional consecutive performance based on a seating capacity of 600, with the consideration that all of the seats will not be filled, and ticket prices of \$40.00 and \$25.00.

Please confirm to us a person's name, street address, and telephone number for use at the time of shipment of the material for your production. You may confirm this information to us by letter when forwarding your payment to us.

Payment of the balance due will be required prior to shipment of the rehearsal material and orchestration and should be received in our offices no later than April 25, 2014 in order to ship the rehearsal material and orchestration as scheduled.

Please be advised that we will be unable to accept your payment if your check is not made payable in U.S. Funds on a U.S. Bank.

You are responsible for the shipping charges both ways. We forward our materials by Federal Express and will invoice your account separately for the Federal Express charges.

We require that you return our materials by a PREPAID EXPRESS DELIVERY service no later than seven days following your final performance. You are responsible for any brokerage, entry fees, custom fees and taxes for the return shipment.
