#### Key points from 2025:

- Currently showing at a \$2570 profit for the 2025 FY.
- Documents have been submitted for the final payment from the City for swipe card access. This will fall in the new FY.
- 70k in Facility improvements: such as Banners, Bar upgrades, repairs and maintenance.
- GST we are now actively receiving bills from the ATO. Approximately \$3k per quarter. We received a \$1500 refund for the last qtr.
- Working through last 20 years of unsubmitted tax returns. There will be a fee incurred for this from ATO.
- Merchandise sales had a better profitable year, compared to previous years. Well done, Peta.

#### **Recommendations for 2026:**

- Set a budget / goal of key items we would like to achieve in 2026 and beyond, rather than trying to do in one season. This will allow for a stronger cash flow and interest building on savings account.
- Team dinners (costing approx \$500 per week). Could reduce this to once a month or seek sponsorship
- Put payments on books for bar staff and trainers

#### 5. Constitution Changes

#### Change to wording of 18.3

Clause 18.3 could be interpreted as the President / executive committee persons can spend any amount, but the intention is that the executive committee decide on the spend, and then the president authorises. Not the president or 2 exec have authority to spend without exec approval.

The constitution does not currently provide for any limit for spend so to protect the committee I propose to amend the clause. Any spend over \$5000 will need full committee approval. We could even put a max of \$20 000 per year without full committee approval.
