Terms and Conditions of Sale

This sale is governed by the laws of Victoria and any dispute will be raised and resolved in Victorian courts. By making a payment against this invoice you agree to and accept all of the below terms and conditions.

1. Definitions

- 1.1 "the Supplier" means Clear Bridge Group Pty Ltd trading as Canopy Outdoor.
- 1.2 "the Customer" or "you" means the person or persons, company or business entity as described on the face hereof.
- 1.3 "the Seller" or "we" means the Supplier.
- 1.4 "the Goods" means the goods or products or services sold by the Seller to the Customer as described on the face hereof or otherwise.

2. Product Disclosures

- 2.1 Printed items by nature fade through use, with the rate depending on local UV levels
- 2.2 PVC items are heavier and more difficult to use than polyester
- 2.3 Some PVC items have a clear protective coating that can peel off through time as it is used
- 2.4 Printed PVC is prone to scratching and wearing on corners / folds
- 2.5 Items need to be packed away dry to avoid moulding
- 2.6 Polyester tops are not suitable for semi-permanent use
- 2.7 Failure to follow our instruction guides voids all warranties
- 2.8 Fabric will degrade in strength, finish, and color through time at a rate depending on local UV levels
- 2.9 Our items require regular maintenance and need to be checked and repaired as described in instruction manuals
- 2.10 Our logo is on our products, notably on the roofs, the carry bags and leg weights
- 2.11 Dyed and printed colors won't match exactly as they are colored through different processes
- 2.12 From production batch to production batch, different dyed items may have minor color differences
- 2.12 As PVC is printed on top of the fabric, it is prone to scratching and this is unavoidable.
- 2.13 Credit card charges are non-refundable
- 2.14 Polyester tops are made from waterproof fabric, and every effort is made to make them 100% waterproof, but due to the nature of sewing, some minor water penetration may occur through seams
- 2.15 Print packages which don't print the entire roof mean a combination of stock dyed fabric and printed fabric will be assembled to make your roof. Some minor color variation may occur between roof panels.

3. Warranty

- 3.1 Fading of materials will occur when the material is exposed to UV lighting, also known as photodegradation. Fading progresses due to usage or age of an item, this is also known as wear and tear and replacements cannot be claimed under warranty conditions.
- 3.2 Unless otherwise negotiated and agreed to in writing, Canopy Outdoor products' warranty begins from the date of purchase the goods are finished and available for collection or delivery.
- 3.3 We guarantee that our product is of merchantable quality and free of faults at the time of purchase. The product will also perform adequately under reasonable circumstances.
- 3.4 Our warranty is a manufacturer's warranty, which means we guarantee against material and workmanship defects. Our products carry no express claims of longevity, strength, quality, etc. unless specifically disclosed.
- 3.5 Issues that arise through accident, misuse, abuse, misapplication, user error, modification, wear and tear, improper installation, negligence, or environmental conditions are not covered by our manufacturers warranty.
- 3.6 Any damage caused by environmental conditions (such as wind, rain, UV) is an insurance issue
- 3.7 All issues with our products will be considered minor issues because they can all be fixed or items replaced easily. We will always attempt to repair or replace the item before considering a refund as an option.

4. Production (Custom made items)

- 4.1 Production start prerequisites include sign off on a design and a cleared payment against the order.
- 4.2 Using payment methods that take time to clear into our account will only delay your order. We cannot be held responsible for slow clearing payments.
- 4.3 Although a production timeframe may be committed to by our staff, factors outside of our control can occur that delay said production. We do not guarantee a firm delivery date.
- 4.4 It is responsibility of the customer to have alternative arrangements in case of a production delay
- 4.5 We employ third party companies and use machinery in our production processes that at times can fail and cause a delay to production. These delays are outside of our control and we cannot be held responsible for any delay occurring from a third party supplier.
- 4.6 Custom made items cannot be refunded or returned and all sales on custom items are final

5. Delays

- 5.1 We are not responsible for any associated costs to the customer that arise as a result of not having one of our products ready for your use.
- 5.2 Any additional costs that need to be incurred as part of a delay will be borne in their entirety by the customer

6. Printing

- 6.1 Artwork will be printed exactly as shown on the revision sent to you. It is your responsibility to check all artwork carefully for errors before approval.
- 6.2 We are able to provide close matches of colors only if we are supplied with Pantone colors. However, printing on different media will result in colors appearing differently, so although we can do our best to match colors, there can be apparent differences due to the substrate material used for our products.

7. Delivery

- 7.1 We use external contractors for the delivery of our products whom are not common carriers, and as such assume no responsibility for the delivery of your items
- 7.2 In the event that a single order is split, where part of an order is delivered before the entire order is completed, it is the responsibility of the customer to ensure the balance of the order is delivered
- 7.3 Any credit against an order that is not used within six months will be forfeited to Clear Bridge Group Pty Ltd
- 7.4 We cannot be held liable for delays with third party couriers. We are never able to guarantee when an order will arrive to you once it has been dispatched from our office. A courier only advises estimated delivery times, if there are any courier delays we cannot be held responsible as this is outside of our control.
- 7.5 Courier costs paid to us are non refundable as we just pass on the cost of delivery from our supplier.
